CONDITIONS OF FACILITY USE:

Your current and future reservation requests may be cancelled if the following should occur: fighting, unseemly conduct, health violations, abuse of staff or property, illegal parking, or failure to remit payment. Individual whose name is on the permit must be at least 21 years of age, be present day of event and have this document on his or her person to prove claim of shelter
- 2) Your group must assume responsibility for providing adequate supervision, facility cleanliness and general order while using the facility.
- 3) No beer trucks allowed.
- 4) Damage and/or destruction of the above named property(s) will result in repair and/or replacement fees billed directly to you.
- 5) In all circumstances, the Organization retains full authority for final approval and denial of facility reservation requests.
- 6) No Refunds Given. The Town is not responsible for inclement weather . All parks open at 7:00AM and close at 8:00PM.
- 7) Shelters cannot be used for profit making ventures.
- 8)Should any challenges occur as to the authenticity of this permit by another group or individual, please contact the Parks Department at 656-2280 between the hours of 7am-11am.

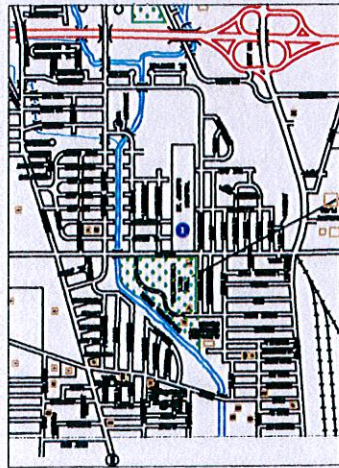

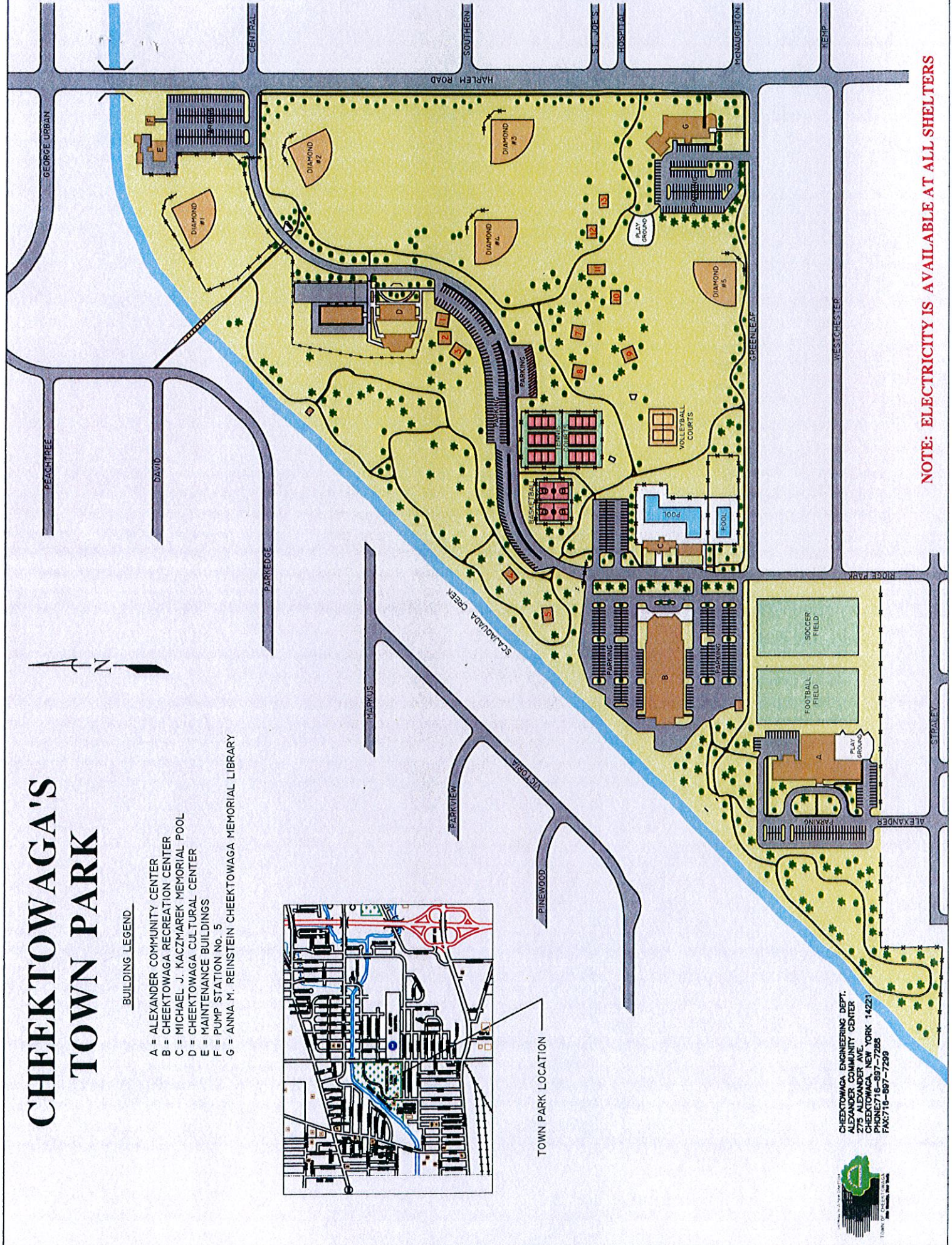
CHEEKTOWAGA'S TOWN PARK

SHELTER PERMIT POLICY

PROHIBITED USES OF PICNIC SHELTERS

The following shall not be allowed in picnic shelters:

1. **Weddings and wedding receptions.**
2. **Bands, DJ'S, sound systems and amplified music.**
3. **Erection of tents and canopies.**
4. **Use of generators.**
5. **Operation of special amusements, including but not limited to animal or mechanical rides.**
6. **On-site caterers and other food vendors/trucks.**
7. **Inflatable play equipment and similar attractions (e.g. bounce houses, obstacle courses, slides, dunk tanks, etc.).**
8. **NO dogs allowed.**
9. **Personal sanitary facilities (i.e. portable toilets).**
10. **Any use of the park area which is not customary for a park in the Town of Cheektowaga shall receive prior written approval of the Director of the Facilities Department.**
11. **NO REFUNDS – ALL RULES WILL BE STRICTLY ENFORCED!**

SHELTER OCCUPANCY LIMITS

Maximum of 50 people per shelter allowed. Guests must comply with NYS Covid-19 guidelines.

ALCOHOLIC BEVERAGES AND BEVERAGE CONTAINERS

1. Only beer (including keg beer), wine and wine coolers are allowed in picnic shelters, no other alcohol is permitted.
2. No glass containers allowed.

PARKING

1. Picnic shelter patrons must park in designated areas.
2. Parking is prohibited on lawn areas.

POOLS

1. Shelter permits DO NOT include free access to Town pools. For pool use information please call the Recreation Department at 897-7207.

FUNDRAISING VENTURES

1. Subject to prior approval via Town Board resolution, not-for-profit/charitable organizations may conduct fundraising in a picnic shelter. Organizations must assure the Town that all labor, material and utility expenses will be borne by such organization. Such organization shall provide the Town with:
 - a. A list of its officers
 - b. A financial statement
 - c. A statement as to the percentage of funds to be directed to the organization
 - d. A statement as to the purpose of the event

BUSINESS PICNICS

Only businesses which have a permanent base of operation in the Town of Cheektowaga and employ 50 or more people in its Town facilities may apply for a picnic shelter permit. Any employee of such business who is a Town resident must obtain the permit.
